LGH, Inc. was incorporated in 1981 by Larry G. Harris, then a 15-year veteran in the oil and gas industry. LGH moved to Rosenberg, Texas from Fulshear, Texas in 1983 and has been in its present location since 1990. LGH has had the same phone number since June of 1983, which is one small indicator of how the company feels about making sure it is available to its customers at all times. The end of 2009, a branch office of LGH, Inc., was opened in Bryan, Texas, to serve Ft. Worth, and surrounding areas.

What LGH Does...

LGH, Inc. is in the business of selling and servicing conventional API 6A new and rebuilt wellhead equipment. LGH recognizes that to use customer inventory as much as possible has advantages to customers in terms of cost and inventory control as well as convenience. LGH also provides High/Low safety hookups, one of the few companies of its kind that provides this service, saving LGH customers the cost and time of having to find a second vendor to hook up and service this critical piece of equipment.

Larry G. Harris – Owner/President (46 years)

Larry started his career in January, 1968 with Houston Engineers in Corpus Christi, TX. He joined Joy Oil Tools of Corpus Christi in 1970. Larry then took a position with Xmas Tree Supply and Seaboard Wellhead Control in 1973, where he was quickly promoted to Vice President.

In 1975, he was made General Manager over Xmas Tree Supply (rebuilt wellheads) and Seaboard Wellhead Control (manufacturing). From 1979 to 1982, Larry was an agent for Foster Oilfield Equipment and was a partner in Acadiana Fittings & Supply. During this time, the LGH Fulshear shop started operations, was incorporated, and began to rebuild wellhead equipment. By the end of 1982, the industry was in a downturn, and Larry had incorporated LGH, made the move to Rosenberg, and opened a full-time shop dedicated to maintaining customer inventory, and selling refurbished and new equipment. A branch office of LGH was opened in Bryan, Texas in 2009.



Teddy Sumrall – Vice President/Operations Manager/Sales (39 years)

Teddy began in 1975 with Xmas Tree Supply in Midland, TX. He moved to Houston in 1976 while working for Xmas Tree Supply and Seaboard Wellhead Control. He ran Sumrall Oilfield Supply in the Houston area starting in 1986, which provided wellhead sales and service for both land and offshore well sites. Teddy joined LGH in 2002 as Vice President and Operations Manager.



Steve Allen-District Manager of LGH, Inc./Bryan, Texas (40 years)

Steve started in 1974, working as a Lease Operator for Sun Oil, in Perryton, Texas and then, managed Frac Tanks. He became Vice President of Completion and Production for HEA Exploration, and went on to become President of HEA. In 2005, he sold the company to Power Chokes, and worked for Power Chokes/Expro Americas, in sales in the Bryan/Ft. Worth, Texas Area. All refurbished equipment is completely disassembled, inspected, machined (if necessary), and hydrostatically tested to API standards. All parts and components are guaranteed for 1 full year unless well conditions or misapplication are the cause of failure.
